Almazar, Raul, RN, MA

Mr. Almazar recently served as the Acting Deputy Director for the State of Illinois Department of Mental Health, with primary responsibility for the 1958 inpatient beds operated by the state. He also recently served as expert consultant in the development of recommendations in the Illinois Equip for Equality's report Private Psychiatric Hospital Initiaitve: Keeping Patients with Mental Illness Safe: Chicago Area Hospitals' Compliance with Restraint and Seclusion Laws.

Most recently she received a national VOICE Award in Los Angeles taking her place with movie stars and others recognized for their contributions in trauma informed care and mental health. In addition to her advocacy she designed a social inclusion booklet for her peers that display options of 'free places' to go for entertainment, training and relaxation.
